**Abstract:**

The last years can be interpreted as the years of crises: first, from 2020 to 2022 the legal systems have been impacted by the COVID-19 pandemic and in 2022 the Russian invasion against Ukraine has been a major issue of the legal systems. Even the Polish and the Hungarian administrative systems and public services have been influenced by the challenges of the pandemic and by the Russo-Ukrainian war. This issue has not been just a threat, but it has even posed a challenge to the legal systems, whose resiliency has been tested by these events and impacts. The Polish and Hungarian regulations – both the general questions of the legal systems and the sectoral solutions (especially the situation in the health care and health administration and in 2022 the immigration and refugee administration) to the challenges of these crises will be examined. The conference is to discuss a comparative approach: two similar but still different Visegrád Countries, Poland and Hungary, will be compared. Thus, the presentations to be delivered will focus on the impact of the COVID-19 and the new situation which has arisen out of the war between Russia and Ukraine on the legal systems, the recent challenges, and opportunities of the public administration on the role and different approaches on the state of emergency as a crisis management tool, and the impact of these crises on several major public service systems. Crisis situations require vertical and horizontal intergovernmental cooperation at both local and European levels. That is why scientists from 33 countries participating in a scientific project funded by the European Commission - COST Action CA20123 - Intergovernmental Coordination from Local to European Governance (IGCOORD) - have been invited to participate in the conference. For this reason, the conference will also be streamed online.
